

FedRAMP Program

Eliminates duplicative efforts Cloud Service Providers (CSP) would have to complete for each agency by providing a common security framework.



Stages to FedRAMP Authorized

FedRAMP Ready

Ready To Start Process, But Needs an Agency Sponsor

A designation provided to CSPs that indicates that a FedRAMP – recognized Third Party Assessment Organization (3PAO) attests to a CSO's security capabilities, and that a Readiness Assessment Report (RAR) has been reviewed and deemed acceptable by the FedRAMP PMO.

FedRAMP In Process

Agency Sponsor/JAB And Working Towards Authorization

A designation provided to CSPs that are actively working toward a FedRAMP Authorization with either the Joint Authorization Board (JAB) or a federal agency.

FedRAMP Authorized

Is An Authorized Vendor

A designation provided to CSPs that have successfully completed the FedRAMP Authorization process with the JAB or federal agency. There are three impact levels based on the :

- Low: Meant for data intended for public use. Data loss would not compromise the agency's mission, safety, finances, or reputation.
- Moderate: Vendors can securely support data such as PII. Agencies that would have an impact if data was compromised.
- High: Agencies with the most sensitive data that would be gravely affected by comprised data.
